

# Pleasant Grove Elementary School Parental Involvement Policy

## PART I. GENERAL EXPECTATIONS

The Pleasant Grove Elementary School agrees to implement the following statutory requirements:

4. The Pleasant Grove Elementary will provide parents of participating children information in a timely manner about Title I, Part A programs that includes a description and explanation of the school's curriculum, the forms of academic assessment used to measure children's progress, and the proficiency levels students are expected to meet by:

- *TEA Publications*
- *Texas Essential Knowledge and Skills*
- *STAAR Standards*
- *PGISD website*
- *Parent-Teacher Conferences (as requested)*

5. The Pleasant Grove Elementary will at the request of parents, provide opportunities for regular meetings for parents to formulate suggestions and to participate, as appropriate, in decisions about the education of their children. The school will respond to any such suggestions as soon as practicably possible by:

- *Campus site-based Planning and Improvement Committee*
- *Fall/Spring Title I Meetings*

6. The Pleasant Grove Elementary will provide each parent an individual student report about the performance of their child on the State assessment in at least math, language arts and reading by:

- *Skyward Family Access*
- *Progress Reports every three weeks*
- *Report Cards every six weeks*
- *Parent/teacher conferences (as requested)*

7. The Pleasant Grove Elementary will take the following actions to provide each parent timely notice when their child has been assigned or has been taught for four (4) or more consecutive weeks by a teacher who is not highly qualified within the meaning of the term in section 200.56 of the Title I Final Regulations (67 Fed. Reg. 71710, December 2, 2002) by:

- *All Pleasant Grove Elementary School staff are 100% highly qualified.*

8. The Pleasant Grove Elementary will provide assistance to parents of children served by the school, as appropriate, in understanding topics such as the following --

- *the state's academic content standards,*
- *the state's student academic achievement standards,*
- *the state and local academic assessments including alternate assessments,*
- *the requirements of Part A,*
- *how to monitor their child's progress, and*
- *how to work with educators:*

through TEA publications, PGISD website, Individual Education Plans, monthly newsletters, progress reports, report cards, parent/teacher conferences, ARD meetings (when appropriate)

9. The Pleasant Grove Elementary will provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training and using technology, as appropriate, to foster parental involvement, by:

- *Providing Skyward Family Access to online gradebooks*
- *Provide teacher e-mail for parent communication purposes*
- *Provide Home & School Connection Newsletters*
- *PGES Website/Facebook Posts*

10. The Pleasant Grove Elementary will, with the assistance of its parents, educate its teachers, pupil services personnel, principals and other staff in how to reach out to, communicate with, and work with parents as equal partners in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools, by:

- *Staff development activities*
- *Development of Parent Involvement Policy*
- *Parent Teacher Organization meetings*

11. The Pleasant Grove Elementary will, to the extent feasible and appropriate, coordinate and integrate parental involvement programs and activities with Head Start, Reading First, Early Reading First, Even Start, Home Instruction Programs for Preschool Youngsters, the Parents as Teachers Program, public preschool, and other programs. The school will also conduct other activities, such as parent resource centers, that encourage and support parents in more fully participating in the education of their children, by:

- *Parent Volunteer Program and Brochure*
- *Assemblies and awards ceremonies*

The Pleasant Grove Elementary will take the following actions to ensure that information related to the school and parent-programs, meetings, and other activities is sent to parents of participating children in an understandable and uniform format, including alternative formats upon request, and, to the extent practicable, in a language the parents can understand:

- *Parent Notification Letter(s) are sent home with students or mailed in a timely manner*
- *Parent Notifications will be sent in a language understandable to parents; and*
- *An interpreter will be provided or our Spanish speaking parents as requested*
